Dear Client,

we inform you that the upcoming 6.1 release of T2S will be available in an external test environment (UTEST) on 5 August and testing may begin on 8 August 2022.

The 6.1 release of T2S will be released into production on 17 September, effective as of 19 September 2022.

The release consists of the resolution of 2 defects.

Test plan

DCPs are invited to test all the defects applicable to their own operational model, indicating in the relevant "R6.1 PBI content incl declaration to testv0.1.xls" form whether they wish to proceed with re-testing and reporting on the status of verification activities on a weekly basis to the address MT-T2S-test@euronext.com

Test schedule

ES-MIL will test all the defects applicable to its operating model in the context of EAC testing reserved for CSDs and will re-run the same tests in the UTEST environment as of 8 August 2022.

In accordance with the plan produced by the European Central Bank, Clients are asked to send final feedback on the final outcome of the tests by 10:00 hours on 29 August 2022, to the address
