Dear Client,

Please note that the upcoming release R2024.FEB of T2S will be available in an external test environment (UTEST) on 19 January and the tests may begin from 22 January 2024.

The release into production of release R2024.FEB of T2S will occur on 16 February 2024, effective as of 19 February 2024.

The release comprises the resolution of 20 defects, 1 change request (not applicable to DCPs).

Test plan

DCPs are invited to re-test all the defects applicable to their own operational model, indicating in the relevant form "R2024.FEB PBI content incl declaration to testv0.1.xls" whether they wish to proceed with re-testing and reporting on the status of progress on verification activities on a weekly basis, again using the same form, to the address MT-T2S-test@euronext.com.

Test schedule

ES-MIL will test all the defects applicable to its operating model in the context of EAC testing reserved for CSDs and will re-run the same tests in the UTEST environment from 22 January 2024.

In accordance with the plan produced by the European Central Bank, Clients are asked to send final feedback on the final outcome of the tests by 10:00 AM on 01 February 2024, to the address MT-T2S-test@euronext.com.
