Documentation required for the assignment of an ISIN code:

For the assignment of an ISIN code it is required to send the necessary documentation which identifies the Issuer and the securities issue.

Issuer identification:

- LEI code (Legal Entity identifier) –mandatory for securities issues registered in the Centralised System managed by INTERBOLSA; recommended for the securities issues not registered in the Centralised System
- Updated copy of the by-laws
- Commercial registration or document evidencing that the Issuer has legal existence and, if it is the case, the amount of its capital
