 - the Morningstar fund selection tool, available for free on Euronext's website, to choose your preferred funds
 - a list of funds compliant with the latest MiFID II regulatory requirements on the transparency of fees

Investing in funds through Euronext Fund Service Paris: A simple STP model via your broker

1. Select your funds using the free Morningstar funds selection tool available on the Euronext website: www.euronext.com/products/funds
2. Find out which brokers are connected to Euronext and have access to your selected funds: www.euronext.com/funds/euronext-fund-services-paris/broker-list
3. Contact your broker via your usual communication channels (email, phone, DMA, chat, etc).
4. Communicate to your broker the side of your transaction (subscription/redemption), the ISIN code of the share class, and the number of shares you want to invest in. Your shares will be credited or debited on your usual account.
