## **B - SPECIAL MARKETING PERMISSIONS FOR CONTRACTS UNAPPROVED FOR DIRECT TRADING**

### **B-1. SECURITIES AND EXCHANGE COMMISSION (“SEC”)**

#### **Amsterdam, Brussels and Paris Markets**

Pursuant to the class relief issued by the SEC on July 1, 2013 and appropriate representations made on 17 September, 2014 on behalf of Euronext Amsterdam, Brussels and Paris to benefit from equivalent treatment, Members of the aforementioned markets may deal on certain Individual Equity, ETF and Equity Index Option contracts with Eligible Institutions in the US only in accordance with Rule 15a-6 under the US Securities Exchange Act of 1934, principally through US registered broker-dealers, as provided in Rule 15a-6.

### **B-2. COMMODITY FUTURES TRADING COMMISSION (“CFTC”)**

#### **Brussels Market**

For index future contracts already listed in section A, offer and sale permission has been obtained in addition to the granting of direct trading access.
