



## Opportunity Investment Management plc. lists on NYSE Euronext in Brussels

**Brussels, 30 September 2010** – NYSE Euronext announces that the company Opportunity Investment Management plc. was admitted to trading today on NYSE Euronext in Brussels via a direct listing without public offer. The prospectus related to this operation is available on [www.oimplc.com](http://www.oimplc.com).

The company is the former Algovision plc., which was delisted from the Brussels market in 2007. The Board of Directors has thereafter restructured OIM and its subsidiaries and liquidated or disposed of loss making and dormant entities. Subsequently the promising, but at the time loss making company Fleischhauer Ingenieurbüro GmbH & Co KG, almost entirely being owned now by OIM, has been restructured. Fleischhauer Ingenieurbüro GmbH & Co KG has been generating annual after tax profits of approximately Euro 1 million plus for the last two years now.

The company was admitted by the direct listing of 17,075,795 existing shares. At the introduction price of €0.59, the market capitalization of OIM reaches €10.300.000. No new shares will be issued.

This will allow both the shareholders at the time of delisting as well as the persons who entered the share capital during the restructuring phase to regain access to the market and the opportunity to benefit from their investment. Furthermore, being listed on NYSE Euronext means that the company will have access to additional sources of finance for intended growth, both organic and through potential acquisitions.”*
