#### **Foreword**

On Friday 10 December 2021 the attribution of Daimler Truck Holding ordinary shares with impact on Single Stock Dividend Futures on DAIMLER (1DAI) ordinary shares. The number of shares (lot) underlying the single stock dividend futures contracts on DAIMLER shares will be substituted with a basket which includes DAIMLER TRUCK HOLDING ordinary shares and DAIMLER ordinary shares.

This operation will be managed in the manner indicated in the Borsa Italiana's Notice n° 40708 dated 6 December 2021, and section B.3.1.6. of the Euronext Clearing Rules.

### 1. Adjustment of positions

At close of today trading day, 9 December 2021, and after the night batch, open positions will be adjusted as indicated below.

- Dividend Futures positions 1DAI
- Dividend Futures positions 1DAI1



According to Borsa Italiana's Instructions, article IA.8.1.6. paragraph 6, the number of shares (lot) underlying of single stock dividend futures contract shall be adjusted.

The adjustment process will be applied by creating the following basket based on the existent contracts:

a) For the series (1DAI) with lot 10.000 DAI shares:

LOT<sub>basket</sub> <sup>1</sup>= 10.000 DAI shares + 5.000 DAIMLER TRUCK HOLDING shares

b) For the series (1DAI1) with 1.000 DAI shares:

#### LOT<sub>basket</sub> = 1.000 DAI shares + 500 DAIMLER TRUCK HOLDING shares

The operations connected with the adjustment that must be made to back Office system of Members which replicate margins of CC&G are described in detail below.

### 2) Classification of Positions with physical delivery
