# MOSELLE RIVER DELIVERY PORTS AVAILABLE FOR RAPESEED EXPIRY IN MAY 2025

Euronext Clearing is pleased to inform its client that the delivery points for MATIF Rapeseed futures contracts along the Moselle River (Belleville, Frouard, and Metz) are now reopened and will be available for the upcoming deliveries, effective from the May 2025 expiry (ECO K5, FREN00027119).

This update follows the previous December 2024 incident, when a cargo ship collided with the lock gates, causing significant damage. The Moselle-Saar-Lahn waterway has now been fully restored to operational capacity.
