- Introduction of the 20C:COAF field into messages concerning financial instruments that Monte Titoli administers either in the capacity of Issuer or Investor CSD.
- Introduction of the exchange rate (EXCH) into SWIFT MT564 and MT566 messages (including Market Claims and Transformations) for interest payment and capital redemption operations.

Test and release dates

The tests will take place between 22 October and 9 November 2018 in the Monte Titoli test environment named "Pre-production", connected to the T2S test environment named "UTEST".
