- the release of the new version of T2S billing reporting may not take place before December 2022
- accordingly, and subject to further announcements, it is expected that debiting for the T2S services for the months of July, August, September, October and November will take place in December 2022 (billing in the month of November) or later.

As a result, invoices issued by Euronext Securities Milan for October will not include information and charges for the billing codes listed below for the months of July to October and, subject to further announcements, the relevant charges should be included in the invoice for November, which is processed in early December.
