- For the testing of Corporate Actions, Monte Titoli has prepared some standard cases and published a test plan with all the operating details in the “T2S Change Management” \ “W3” folder of the documents section of MT-X. The objective of the tests is to verify the correct processing of events, according to the usual operating steps (corporate action information, accounting messages, payments, instructions, etc.).
- Monte Titoli provides support for any requirements and awaits, by the close of business on Tuesday 15 November, feedback on the status of execution of the tests by the individual clients concerned.
