Content of the release:

– switch between two ESMIL accounts belonging to same Intermediary

Within the creation and authorization menu a new field is now available to allow a quick reverse the direction of the operation and the main details in order to create the second leg of the securities round between two accounts in ESMIL.

The new field appears after the insertion of the first trade in the scenarios where its use is permitted.

The possibility of entering against payment transactions towards a counterparty in the US (PSET =DTCC) has been removed to facilitate customers in correctly entering transactions via our platform

– **Description change for fields Bic party 1 and party 2 (English version only)**

Within the creation and research menù, in english only, the following fields have been amended:

- From Cod Bic Pty2 Ctrp to Ctrp Pty2 BIC

– **New Error Result for CVT and PCR trades**

In the creation menu, when entering CVT and PCR trades on inflation-indexed securities, in the event that the reference inflation is not available on the settlement date set in the trade, the message "Reference inflation not found" will be provided.
